BAYRIDGE PAC CONSTITUTION AND BYLAWS

Constitution

SECTION I - NAME

The name of this Council is Bayridge Elementary School Parent Advisory Council (Bayridge PAC)

The Council will operate as a non-profit organization with no personal financial benefit accruing to members.

The business of the Council will be unbiased in respect of race, religion, gender, politics, sexual orientation, and physical or mental ability.

Section II - PURPOSES OF THE COUNCIL

The purposes of the Council will be:

- 1. To promote the education and welfare of students in the school
- To encourage parent involvement in the school, and to support programs that promote parent involvement
- To advise the school board, principal, and staff on any matter relating to the school, other than matters assigned to the school planning council
- To participate in the work of the school planning council through the Council's elected representatives
- To promote the interests of public education and, in particular, the interests of Bayridge Elementary School
- 6. To provide leadership in the school community
- To contribute to a sense of community within the school and between the school, home, and neighbourhood
- To provide parent education and professional development, and a forum for discussion of educational issues
- To assist parents in obtaining information and communicating with the principal and staff about their child's progress or other concerns
- To assist the principal and staff in ensuring the highest safety standards are maintained in the school and neighbourhood
- 11. To organize and support activities for students and parents
- To provide financial support for the goals of the Council, as determined by the membership
- To advise and participate in the activities of Bayridge Elementary School Parent Advisory Council

Section III -- INTERPRETATION OF TERMS

"community organizations" means groups that demonstrate an interest in education and are not already included in the scope of the Council's constitution and bylaws

"district" means School District No. 36 (Surrey)

"DPAC" or "district parent advisory council" means the parent advisory councils organized according to the School Act and operating as a district parent advisory council in School District No. 36 (Surrey)

"PAC" or "parent advisory council" means the parents organized according to the School Act and operating as a parent advisory council in Bayridge Elementary School

"parent" is as defined in the School Act and means

(a) the guardian of the person of the student or child,

(b) the person legally entitled to custody of the student or child, or

(c) the person who usually has the care and control of the student or child

and, for the purposes of these bylaws, means the parent or guardian of a child or children enrolled in School District No. 36 (Surrey)

"school" means any public elementary or secondary educational institution as defined in the School Act operating within School District No. 36 (Surrey)

"SPC" means the school planning council created for Bayridge Elementary School according to the School Act

Bylaws

SECTION I - MEMBERSHIP

Voting members

 All parents and guardians of students registered in Bayridge Elementary School are voting members of the Council.

Non-voting members

- Administrators and staff (teaching and non-teaching) of Bayridge Elementary School may be invited to become non-voting members of the Council.
- Members of the school community who are not parents of students registered in the public school system may be invited to become non-voting members of the Council.
- 4. At no time will the Council have more non-voting than voting members.

Compliance with bylaws

5. Every member will uphold the constitution and comply with these bylaws.

Section II - MEETINGS OF MEMBERS

General meetings

- General meetings will be conducted with fairness to all members.
- General meetings will be held not less than four times during the school year. One of those meetings will be the annual general meeting.

Conduct

- At general meetings, members will not discuss individual school personnel, students, parents, or other members of the school community.
- The Council will refrain from partisan political action or other activities that do not serve the interests of the school or the public school system.

Notice of meetings

Members will be given reasonable notice of general meetings.

Notice of meetings can be sent in various ways—by flyer, newsletter, email, or website. A calendar of meetings for the year satisfies the requirement for reasonable notice.

Section III - PROCEEDINGS AT GENERAL MEETINGS

Quorum

A quorum for general meetings will be seven voting members.

If at any time during a general meeting a quorum ceases to be present, business then in progress must be suspended until there is a quorum present or until the meeting is adjourned or terminated.

A quorum is the minimum number of voting members that need to be present at a meeting to make decisions. The requirement for a quorum ensures that a representative number of voting members are present in the room when decisions are made. The quorum cannot be waived or suspended, even by unanimous consent.

Voting

Except as provided elsewhere in these bylaws, all matters requiring a vote will be decided by a simple majority of the votes cast (50% plus 1).

 In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.

Members must vote in person on all matters. Voting by proxy will not be permitted.

Except as provided elsewhere in these bylaws, voting is by a show of hands or, where requested by two voting members present, by secret ballot.

7. A vote will be taken to destroy the ballots after every election.

Section IV -- EXECUTIVE

Role of executive

The executive will manage the Council's affairs between general meetings.

Executive defined

The executive will include the president, vice-president, secretary, treasurer, immediate past president, and such other members of the Council as the membership decides.

Eligibility

Any voting member of the Council is eligible to serve on the executive, except employees or elected officials of School District No. 36 (Surrey) or the Ministry of Education.

Perception of Bias – Councils need to appear to be representing the voice of parents and protecting the integrity of their membership. Members who are school board or Ministry of Education employees or elected officials may be seen as having a bias and not speaking or acting solely on behalf of parents.

Election of executive

The executive will be elected at each annual general meeting.

Term of office

- The executive will hold office for a term of one year beginning immediately following the election.
- No person may hold the same executive position for more than three years.

Vacancy

 If an executive member resigns or ceases to hold office for any other reason, the remaining executive members may appoint an eligible member of the Council to fill the vacancy until the next annual general meeting.

Removal of executive

- The members may, by a majority of not less than 75% of the votes cast, remove an executive member before the expiration of his or her term of office, and may elect an eligible member to complete the term.
- Written notice specifying the intention to make a motion to remove the executive member must be given to all members not less than 14 days before the meeting.

Remuneration of executive

11. No executive member may be remunerated for serving on the executive, but may be reimbursed for expenses reasonably and necessarily incurred while engaged in the Council's affairs.

Section V - EXECUTIVE MEETINGS

Meetings

 Executive meetings will be held at the call of the president. At least one meeting will be held before each general meeting.

Quorum

A quorum for executive meetings will be a majority (50% plus 1) of the members of the executive.

Notice

3. Executive members will be given reasonable notice of executive meetings.

Voting

- All matters requiring a vote at executive meetings will be decided by a simple majority of the votes cast (50% plus 1).
- In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.

Section VI - SCHOOL PLANNING COUNCIL, DISTRICT PARENT ADVISORY COUNCIL, AND EXTERNAL COMMITTEE REPRESENTATIVES

School Planning Council representatives

Three representatives to the school planning council (SPC) must be elected annually
from among the voting members who are not employees or elected officials of any school
board or the Ministry of Education. One of these representatives must be an elected
member of the Council executive.

District Parent Advisory Council representative

One representative to the (name of your DPAC) may be elected annually from among the voting members who are not employees or elected officials of School District No. 36 (Surrey) or the Ministry of Education.

Election of SPC and DPAC representatives

The election of representatives to the SPC and DPAC must be by secret ballot.

Term of office

4. SPC and DPAC representatives will hold office for a term of one year.

Vacancy

If an SPC or DPAC representative resigns or ceases to hold office for any other reason, the membership may elect an eligible member of the Council to fill the vacancy for the remainder of the term. Such election must be by secret ballot.

External committees

- The membership or executive may elect or appoint a member who is not an employee or elected official of School District No. 36 (Surrey) or the Ministry of Education to represent the Council on an external committee or to an external organization.
- 7. The representative will report to the membership or executive as required.

Section VII - CONDUCT OF EXECUTIVE AND REPRESENTATIVES

Code of ethics

 On election or appointment, every executive member and representative must sign and agree to abide by a code of ethics acceptable to the membership.

Representing the Council

Every executive member and representative must act solely in the interests of the parent membership of the Council.

Privilege

 Any information received in confidence by an executive member or representative from school personnel, a student, parent, or other member of the school community is privileged and must not be divulged without permission of the person giving the information.

Disclosure of interest

- 4. An executive member or representative who is interested, either directly or indirectly, in a proposed contract or transaction with the Council must disclose fully and promptly the nature and extent of his or her interest to the membership and executive.
- Such an executive member or representative must avoid using his or her position on the Council for personal gain.

Section VIII - DUTIES OF EXECUTIVE AND REPRESENTATIVES

A. The President will

- a. speak on behalf of the Council
- b. consuit with Council members
- c. preside at membership and executive meetings
- d. ensure that an agenda is prepared
- e. appoint committees where authorized by the membership or executive
- f. ensure that the Council is represented in school and district activities
- ensure that Council activities are aimed at achieving the purposes set out in the constitution
- h. be a signing officer
- submit an annual report

The meeting agenda is usually the president's responsibility. It is good practice to consult with the executive, membership, principal before the meeting to give them an opportunity for input.

The president usually gives a report at each meeting outlining work done and issues considered since the last meeting.

B. The Vice-President will

- a. support the president
- b. assume the duties of the president in the president's absence or upon request
- c. assist the president in the performance of his or her duties
- d. accept extra duties as required
- e. be a signing officer
- f. submit an annual report

C. The Secretary will

- a. ensure that members are notified of meetings
- b. record and file minutes of all meetings
- keep an accurate copy of the constitution and bylaws, and make copies available to members upon request
- d. prepare and maintain other documentation as requested by the membership or executive
- e. issue and receive correspondence on behalf of the Council
- f. ensure safekeeping of all records of the Council
- g. may be a signing officer
- h. submit an annual report

If changes are made to the constitution and bylaws, they should be dated and initialed and a copy placed in the school office for safekeeping.

Financial records should be kept for seven years. Other documents may be kept according to their value or precedent-setting nature. Minutes can be a valuable history of the council.

D. The Treasurer will

- a. be one of the signing officers
- b. ensure all funds of the Council are properly accounted for
- c. disburse funds as authorized by the membership or executive
- d. ensure that proper financial records and books of account are maintained
- e. report on all receipts and disbursements at general and executive meetings
- f. make financial records and books of account available to members upon request
- g. have the financial records and books of account ready for inspection or audit annually
- h. with the assistance of the executive, draft an annual budget
- ensure that another signing officer has access to the financial records and books of account in the treasurer's absence
- submit an annual financial statement at the annual general meeting in an approved format

E. The DPAC Representative will

- attend all meetings of (name of your DPAC) and represent, speak, and vote on behalf of the Council
- b. maintain current registration of the Council
- c. report regularly to the membership and executive on all matters relating to the DPAC
- d. seek and give input to the DPAC on behalf of the Council

- e. receive, circulate, and post DPAC newsletters, brochures, and announcements
- f. receive and act on all other communications from the DPAC
- g. liaise with other parents and DPAC representatives
- h. submit an annual report

F. Members-at-Large (Directors) will

- serve in a capacity to be determined by the Council at the time of election, and at other times as the Council requires
- b. submit an annual report

G. The immediate Past President will

- a. advise and support the membership and executive
- b. provide information about resources, contacts, and other matters
- c. submit an annual report

Annual reports are important because they

- provide an opportunity to review personal and council goals and achievements
- provide a record of actions taken
- outline responsibilities for those considering running for an executive position

H. The School Planning Council (SPC) representatives will

- a. attend all meetings of the school planning council (SPC)
- b. represent, speak, and vote on behalf of the Council at SPC meetings
- c. request and take direction from the membership and executive
- d. be strong advocates for meaningful parent involvement in the school and school planning
- e. provide a written report to all general and executive meetings
- f. attend general and executive meetings as directed by the membership or executive
- g. submit an annual report

Section IX - COMMITTEES

- The membership and executive may appoint committees to further the Council's purposes and carry on its affairs.
- The terms of reference of each committee will be specified by the membership or executive at the time the committee is established, or by the committee at its first meeting, as the membership or executive decide.
- 3. Committees will report to the membership and executive as required.

Section X - FINANCIAL MATTERS

Financial year

1. The financial year of the Council will be September 1 to August 31.

Power to raise money

2. The Council may raise and spend money to further its purposes.

Bank accounts

All funds of the Council must be kept on deposit in the name of the Council in a bank or financial institution registered under the Bank Act. Signing authority

The executive will name at least three signing officers for banking and legal documents.
 Two signatures will be required on all of these documents.

Annual budget

5. The executive will prepare a budget and present it to the membership for approval.

Non-budgeted expenditures

6. The executive will present all proposed expenditures beyond the current budget for approval at the next general meeting except that the executive may authorize unbudgeted expenditures which, in the aggregate, amount to less than \$500.00 provided that such expenditures are presented in the Treasurer's report at the general meeting following such expenditure.

Treasurer's report

7. A treasurer's report will be presented at each general meeting in an approved format.

Auditor

Members at a general meeting may, but are not required to, appoint an auditor to audit the financial records of the PAC.

Section XI - CONSTITUTION AND BYLAW AMENDMENTS

 The members may, by a majority of not less than 75% of the votes cast, amend the Council's constitution and bylaws.

2. Written notice specifying the proposed amendments must be given to the members not

less than 14 days before the meeting.

Where the proposed amendments exceed one page, they need not be given to every member, but must be posted in a conspicuous place in the school or made accessible to all members.

Section XII - PROPERTY IN DOCUMENTS

All documents, records, minutes, correspondence, or other papers kept by a member, executive member, representative, or committee member in connection with the Council shall be deemed to be property of the Council and shall be turned over to the president when the member, executive member, representative, or committee member ceases to perform the task to which the papers relate.

Section XIII - DISSOLUTION

In the event of winding up or dissolution of the Council, and after payment of all debts
and costs of winding up or dissolution, the assets and remaining funds of the Council
shall be distributed to another parent advisory council or councils in School District No.
36 (Surrey) having purposes similar to those of the Council, as the members of the
Council may determine at the time of winding up or dissolution.

2. In the event of winding up or dissolution, all records of the Council shall be given to the

principal of Bayridge Elementary School.

Section XIV - GOVERNANCE AND USE OF BAYRIDGE PAC WEBSITE AND HOT LUNCH ORDERING SITE

The purpose of the "said" website is for The Parent Advisory Council aka 'PAC' to communicate to its members; information which relates to PAC issues, events, and fund raising. PAC issues are defined as matters of importance to the membership at large; events are defined as on-goings which promote PAC matters; and fund raising is defined as any PAC exec. driven initiative to raise monies for a specific purpose.

- 1. Within the website is a classified section which shall be used for PAC sponsors such as parents who wish to advertise with a donation from proceeds raised; and student classifieds which pertain to services offered by students such as tutoring, piano lessons, baby-sitting etc. The PAC reserves right to refuse postings to the classified section should they be deemed inappropriate for the site.
- The homepage of the website is designated for PAC business only and is governed in this regard for the intent not to become a place of advertisement. PAC sponsors are directed to use the classified. PAC sponsors may be listed on the homepage at the discretion of the PAC Exec.
- 3. The PAC may send out a maximum of one weekly e-mail. The purpose of this governance is to ensure that members are protected from an abuse of the e-mail list and system and maintain its integrity and intent. In the event that the school principal has a situation which would be helped by the use of the e-mail list and system; the use by the principal shall not be unreasonably withheld. E-mails will only contain information that pertains to PAC issues, events, and fundraisers; as well as school calendars events, newsletters and principal reports, issues or concerns.
- 4. Should the integrity and confidentiality of the e-mail list ever be breached in a way which might be considered by any member of the PAC to be harmful or malicious; the initial action shall be to contact the school principal and request guidance on the matter.
- The PAC will elect an officer to fill the position of 'Web Manager'. The Web Manager will be responsible for all aspects pertaining to the said website. This position may be held for a maximum of three consecutive years.
